- c) You will be asked to make the payment through SEPA credit transfer on a secure bank account within 14 working days. The money will not be used and is refundable at any time on demand.
- d) Newron Motors will confirm the payment receipt via email

When the production will start, you will be notified and a purchase contract will be made.

### 2) Withdrawal

This reservation does not guarantee you a motorcycle and the characteristic, appearance and specifications may differ from the time you placed your reservation and the start of the production.
